Showa Shell Sekiyu K.K. and Idemitsu Kosan Co., Ltd. executed a share exchange agreement as of October 16, 2018, and have proceeded with preparations for the business integration to be consummate on April 1, 2019.

In connection with the above, both companies hereby announce that all of the required matters for the business integration, including the share exchange agreement, were approved as follows at their extraordinary general meetings of shareholders which were held separately today.
